CHARLTON FORGE POOL RULES

Pool rules are in accordance with Cobb County Board of Health Regulations, CFHA Board of Directors and Liability Insurance requirements.

GENERAL RULES

- Use of the pool is for CFHA members, their families, social guests and domestic employees in service of their duties. A CFHA member must accompany guests.
- Violation of pool rules can result in dismissal from the pool, denial of privileges and/or members being individually assessed for damages.
- No use of the pool unless dues are paid in full.
- Food and drinks are allowed in the Pavilion area. Members are required to clean up after themselves and their guests. Use appropriate trash bins and recycling bins (for cans, bottles and plastics), and wash up spills (hose from clubhouse will reach pavilion)
- Pool furniture must remain in pool area.

POOL RULES

- No children under 10 permitted without an adult
- All persons are required to obey lifeguard
- No running or roughhousing
- No pets
- No glass or food in pool area
- No profanity
- No harassment
- No smoking in pool area
- No water balloons or tennis balls
- Toys such as floats, tubes etc. are permitted at lifeguard's discretion
- No climbing on Lifeguard stand

POOL HOURS

Monday – Saturday 11 am to 9 pm, Sunday 1 pm to 8 pm

LIFEGUARDS

- All Pool users are required to obey lifeguard
- If an adult is in disagreement with the lifeguard, the issue is to be taken to the CFHA Board of Directors, since the lifeguard is responsible for upholding the policies of the Board.
- The Lifeguard is not responsible for babysitting
- Lifeguard is required to take a break every hour. This time is known as 'adult swim' and children under 18 are not allowed in the pool or on the steps until break is over. Infants are allowed in pool with parents at this time
- No one is allowed to accompany lifeguard into the Clubhouse

CHILDREN

• Lifeguards are hired to watch the general pool population. Parents are expected to keep close watch on the children learning to swim.

- Children under 10 years of age must be accompanied by and under direct adult supervision (16 or over). Children 10 to 13 must be able to swim (as determined by lifeguard) to be in attendance at the pool without an adult.
- All babies and toddlers needing diapers are required to wear plastic pants over cloth (not paper)
 diapers, and children who appear sick are not allowed in the pool area. For the health of all, the
 lifeguard is required to close the pool(s) whenever a child defecates in the pool and parents are
 required to notify the lifeguard if this does occur.

PRIVATE PARTIES

No private parties larger than 10 people are allowed during pool hours. For all private parties:

- Contact the Pool Committee for approval and scheduling
- Host must hire a lifeguard from our Pool Management Company, or have a Red Cross certified guard, for the full duration of the event
- Host must secure and submit to the Pool Committee signed waivers from each non-CFHA resident guest or parent prior to the date of the party (available from Pool Committee or Board Members).
 CFHA members are not required to submit waivers.
- Due to insurance/liability issues, adult swimming during closed hours will be handled as a private party and those who are interested may wish to form groups to share cost of hiring a guard and setting regular schedules outside of operating hours.
